#### Warning on two Scams.

A scam has been identified regarding bags being pushed through doors requesting food. There is a card in the bag but no contact details. A vehicle registration number has been handed to the police who are investigating this scam alongside Trading Standards.

Owners of motorcycles who advertise them for sale are receiving interest from prospective buyers. When they inspect the cycles they imply that they are not what they are looking for only to return to steal them.

#### Parking in Caverswall Road, Blythe Bridge.

A meeting can be arranged regarding the above with the Parish Council, County Councillor W. Day, Staffordshire County Council Highways Officer and the concerned resident.

#### 30 mile speed limit sign in Stallington Road, Blythe Bridge.

Signs can only be erected in accordance with current legislation. A Staffordshire County Council highway officer will undertake a site visit.

#### 20 mile speed restriction around Schools.

A request has been made for the proposed 20 mile speed restriction around Blythe Bridge High School to be extended to cover Forsbrook Primary School.

#### 9. PLANNING.

# 9.1 Planning Applications:

00854/REM – 11 Cypress Grove, Blythe Bridge – landscaping of the site.

00847/OUT-56 Cheadle Road, Forsbrook – erection of 2 detached two storey dwellings.

Chairman Councillor Mrs. G. Burton read to members an extract from the accompanying Design and Access Statement for the above planning application 00847/OUT as detailed below:

"This application seeks outline planning consent for the erection of 2no. detached dwellings served by a new vehicular access off the Cheadle Road. The application represents a resubmission following a previously refused scheme for 4no. dwellings which included the demolition of the existing building on site. The Council expressed concern that this building is a heritage asset and should be retained. therefore now seeks to retain the building, thus overcoming the previous objection to The proximity of the retained property, its associated the redevelopment of the site. outbuildings and the presence of a number of important, mature trees serves to reduce the developable area of the site somewhat. It is considered that the erection of 2no. dwellings on the site is appropriate having regard to these constraints. The proposed dwellings will be no more than two storeys in height with the aim of ensuring that the new development does not impinge upon the setting of the historic asset when viewed from the surrounding area. The existing three storey property and its associated garage and outbuildings will be retained. The proposed dwellings will be sited alongside the existing retained building, in such a way that they will safeguard the heritage asset and achieve a satisfactory relationship with surrounding development. Each dwelling will benefit from its own private amenity space and will also provide for a minimum of two off-road parking spaces to serve each dwelling along with associated manoeuvring space. A tree survey was commissioned to accompany the previous application and it is clear from this survey that the siting of the proposed two dwellings will not impinge upon the health or well being of the two most important trees on the site (Copper Beech T1 and Sycamore T2). A number of poorer quality trees are likely to be removed to accommodate the proposed development, but there is capacity within the site for supplementary planting and landscaping to be undertaken in mitigation. The application is made in outline with all matters except access The detailed design and appearance of the reserved for subsequent approval. development is therefore not known at this stage. It is nevertheless anticipated that the design of the proposed dwellings will take its cues from development in the surrounding area and in particular the adjacent heritage asset. Access to the site is to be secured via a new access off the Cheadle Road. This is considered to be the only suitable location for a new access in terms of achieving an acceptable level of visibility on egress."

00899/FUL – 4 Oakdene Close, Blythe Bridge – single storey side and rear extensions.

00827/FUL – Farm Cottage, Cheadle Road, Blythe Bridge – dropped kerb.

#### **RESOLVED:**

00854/REM - To raise no concerns providing the landscaping scheme fits in with the street scene and is not visually unacceptable for adjacent neighbours.

00847/OUT – To state that these proposals are an improvement on the previous application that was refused and to raise no concerns providing the area of the site is large enough to accommodate the additional dwellings, that the scale and design are in keeping and that the privacy of the adjacent neighbour is not compromised.

00899/FUL – To raise no concerns providing the scale and design are in keeping and that there is no adverse effect on neighbouring properties.

00827/FUL - To raise no concerns.

Planning Application 00177/OUT – 'Westview' Quabbs Lane, Forsbrook – erection of dormer bungalow.

It was noted that Mr. P. Mellor has appealed against the refusal of Staffordshire Moorlands District Council to allow planning permission for the erection of a dormer bungalow. Representations needed to be made before the 28<sup>th</sup> September in writing (three copies) quoting reference APP/B3438/A/12/2181029/NWF to the Planning Inspectorate, Room 3/26b, Temple Quay House, 2 The Square, Temple Quay, Bristol, BS1 6PN.

Eleven members of Council wanted to purchase one of the above. County Councillor W. Day advised that he could arrange to order these at a cost of £10.00. It was agreed for the clerk to place the order.

#### Missing Dog Fouling Bin – Blythe Bridge and Forsbrook Village Hall.

The clerk has reported the above to Staffordshire Moorlands District Council. They no longer supply new bins but can install a used bin for £65.00. The Chairman of the Village Hall Committee has been informed.

# Flower Planters in the Centre of Blythe Bridge.

On the 5<sup>th</sup> October 2012 recently planted pansies from one of the planters were uprooted and scattered around the paved area. This happened between 2.30-3.30pm. Blythe Bridge High School has been informed and Mr. Mottram is investigating to see if anyone at the High School has any information. The police have also been informed and are checking CCTV footage.

#### Motor Bikes.

Motor bikes have been on the Recreation ground in Blythe Bridge and also on the open space adjacent to the Butchers Arms in Forsbrook between lunchtime on Wednesday 3<sup>rd</sup> October 2012 and 7.30 am on 4<sup>th</sup> October 2012. The police have been informed and have the matter in hand.

Graffiti on the bus shelter in Cheadle Road opposite Bridgwood Road in Forsbrook has been reported to the police. The graffiti has been removed.
