#### 3. OPEN SESSION.

#### 3.1 Residents Issues.

#### 3.1.1 Pedestrian Crossing, Forsbrook.

Mrs. June Bassett asked if there was any update on the provision of a Pedestrian Crossing in Forsbrook.

Chairman Councillor Mrs. G. Burton advised that Council were waiting for County Councillor W. Day to arrange a meeting to discuss all outstanding highway issues, including the Safer Routes to School Scheme, Divisional Highway Plan and Local Transport Plan.

# 3.1.2 Mr. & Mrs. Carter, 25 Cedar Avenue, Blythe Bridge.

Chairman Councillor Mrs. G. Burton read a letter of thanks from the above for the help and support Council gave residents with regard to the planning application for residential development at 23 Cedar Avenue, Blythe Bridge and also for all Council's efforts on behalf of the community.

# 3.1 County Council Report.

In the absence of County Councillor W. Day there was no report.

Chairman Councillor Mrs. G. Burton said she was hoping County Councillor Day would have been present because she felt Council wanted clarification on the Highways Community Team directives. The intended work identified by Staffordshire County Council for the Highways Community Team to carry out when they were in the Parish from 23<sup>rd</sup> September to 29<sup>th</sup> September was the removal of weeds in various areas, which she presumed had been collated from 'Clarence' reports over the years, which could be viewed by Forsbrook Parish Council as low priority and would not be a problem if regular weed maintenance treatment was undertaken. She said that she felt more important jobs could be undertaken such as maintenance work on blocked drains which the clerk has already reported to the Highways Defects Department and also included on previous Highway Community Team work schedules.

# 4. INFORMATION AND REPORTS FROM REPRESENTATIVES ATTENDING 'OUTSIDE' MEETINGS'.

Chairman Councillor Mrs. G. Burton reported that she had attended the Parish Assembly meeting on 16<sup>th</sup> September 2010 along with Councillor Miss S. Farr and Councillor A. J. Mould and that minutes from the meeting will be forwarded in due course. She also said that she had represented Council at Werrington Chairman's Civic Service on 5<sup>th</sup> September, which was very enjoyable.

Councillor A. J. Mould reported that he had recently attended a Moorlands Partnership Board Meeting. The Moorlands Partnership Board has received £50000 funding for year 2010/2011 and at the moment there is still £25000 left in the budget. He suggested Council consider replacing the metal gate to what was the entrance into the cemetery field with a continuation of the stonewall and applying for funding. This access/egress is no longer needed and does not meet highway safety criteria. **Agreed to investigate.**

# 9.1 Planning Applications:

00681/FUL – Land adjacent to Road House Garage, Uttoxeter Road, Draycott in the Moors – change of use to provide 3 No. Parking Spaces.

00728/FUL – The Recreation Ground, Mount Road, Blythe Bridge – proposed front extension to existing changing rooms.

00747/FUL – The Limes, Cheadle Road, Blythe Bridge – conversion of 1 dwelling to 2 dwellings.

000641/FUL - Roshni Restaurant, 19 Cheadle Road, Forsbrook - change of use of outbuilding to auxiliary accommodation/holiday accommodation.

#### **RESOLVED:**

To respond to the above planning applications as follows:

#### 00681/FUL

"Members of Forsbrook Parish Council have studied the above planning application and have concerns regarding the proposals.

The site is located within green belt and planning permission was refused for car sales on this site in October 1998 on the grounds that it was "inappropriate development within the green belt as it was detrimental to its openness and visual amenity contrary to the provision of national and local planning policies".

Your officer should consider refusing the above application on the same grounds."

#### 00728/FUL

"Members of Forsbrook Parish Council do not wish to comment on the above planning application as it is one that we have submitted."

#### 00747/FUL

"Members of Forsbrook Parish Council have studied the above plans and reexamined previous planning applications on the same site - 00200/FUL for the erection of detached bungalow and 00427/FUL for the conversion of former coach house to 2 storey dwelling, both of which have been approved.

Originally, on this site was one large semi detached house. The site now includes three substantial properties and this later proposal, if approved will mean that from one original property there will be four properties. One can presume that each property will have at least two cars and members consider that the access/egress is not wide enough for two cars to pass. The access/egress point is on an extremely busy road close to one High School and one Primary School and is on a very bad bend and poses highway safety issues. There is now also the presumption against 'garden grabbing'. Already a precedent has been set for other properties to convert gardens for residential development. Only nearby two properties The Rectory and The Furlongs have had planning permission refused for similar development.

Forsbrook Parish Council believe that by submitting individual planning applications for development on the site, with each one being determined on its own merit, the consequences of overdevelopment and highway safety have been somewhat compromised as opposed to if one application for the whole development had been submitted at the same time.

Trusting your Officer will consider our concerns when making a decision."

#### 000641/FUL

- "Members of Forsbrook Parish Council have studied the above planning application and have several concerns.
- 1. The site lies within a flood zone area and the property has been flooded several times during the last ten years. Staffordshire Moorlands District Council is in possession of photographic evidence of this.

- 2. The proposed development lies within an area, which could be subject to current coal mining or hazards resulting from past coal mining. Such hazards may currently exist, be caused as a result of the proposed development, or occur at some time in the future.
- 3. The proposals are for accommodation for owner/staff or holiday lets at the rear of the staff car park. Additional living accommodation has recently been approved on the first floor of Roshni's Restaurant. The car park adjacent to the Restaurant is used by staff and customers and is extremely busy. Residents, customers and staff using this busy car park will obviously pose a pedestrian/vehicle conflict to any residents needing to access the proposed accommodation to the rear of the car park either by car or on foot. The existing access/egress is already unsuitable across a very busy pavement on a bend and on a junction.
- 4. Government has issued guidelines against 'garden grabbing' for development.
- 5. The applicant states that the building is currently used as a store by Roshni Restaurant but that the original use may have been a coach house or garage. As far as Council is aware the outbuilding has never been used as a coach house.

Trusting you Officer will consider our concerns when making a decision."

427 Uttoxeter Road, Blythe Bridge.

Councillor Mrs. S. M. Edwards agreed to check with the Planning Department to ascertain if the large barn/stable structure recently erected in the agricultural field to the rear of the above met with planning guidelines.

Councillor Mrs. P. Shufflebotham, Chairman of the Cemetery Committee said she had no matters to bring to the attention of Council.

- 10.2 Cemetery Issues.
  - 10.2.1 Councillor J. W. Burgess reported that he had received a telephone call from a resident complaining about the grass not being collected by the contractor when mowing the cemetery.

Chairman Councillor Mrs. G. Burton advised that this was not part of his contract and the cost for undertaking such work would be prohibitive.

10.2.2 Councillor Mrs. N. A. Stanier asked for permission to plant more spring bulbs at the cemetery. **Agreed.** 

#### 11. ENVIRONMENT:

11.1 Environment Report.

Chairman Councillor Mrs. G. Burton read out an article from the Sentinel printed on 11<sup>th</sup> September with regard to community centres. An extract from the news article is appended below:

"Almost a dozen youth and community centres could be saved if residents come up with plans to revive them. Teenagers, pensioners and other social groups feared they were going to be left homeless after Staffordshire County Council announced the buildings were on a closure list three years ago. But now, the new Conservative-led authority has urged communities to draw up their own plans for reducing costs to make the They could include handing over the management to voluntary centres viable. committees, sharing the buildings with other organisation, increasing charges for In some cases, youth clubs could switch to events or putting on more activities. alternative premises nearby and the old buildings be sold off. But Councillor Ben Adams, cabinet member for communities and culture said plans needed to be realistic and he revealed two of the buildings previously unaffected by the closure plans are They are Knutton Youth Centre and Gnosall Youth Centre, near now under review. Villagers in Gnosall only have until the end of this year to come up with their plan for the building. In Knutton, residents have two years to turn it around. Those which could get a reprieve include youth and community education centres in Blythe Bridge and Bradwell, where residents are being given two years to drum up ideas."

Chairman Councillor Mrs. G. Burton said it was appalling that the first indication of what was being proposed was the article in The Sentinel when the Parish Council, since the conception of the Egerton Centre and new Library has asked to be involved and to be included in meetings.

#### **RESOLVED:**

To write to Staffordshire County Council referring to previous correspondence and asking at what point they were going to consider consulting the Parish Council and enquire as to the current position with regard to the service level agreement that was being drawn up together with usage and income source.

For reference purposes a copy of the letter the clerk has sent to Councillor Ben Adams is appended hereunder.

"The recent news article printed in The Sentinel on 11<sup>th</sup> September 2010 under the heading 'Social groups can save their centres' was discussed at our Parish Council meeting on Monday 20<sup>th</sup> September 2010.

Councillors were quite appalled that this was their first knowledge of what is being proposed and it therefore seems obvious that for whatever reason you do not want any input from us. Forsbrook Parish Councillors receive no remuneration for the work they do and as the elected body we try to listen to the needs and aspirations of our community and help to bring about improvements within the Parish. If you refer to previous correspondence you will see that from the conception of the Egerton Centre we have been very interested in playing a part and when the Service Level Agreement was being drawn up, which we understand has now come to a standstill, we asked to be included in meetings/discussions.

We have recently published our Parish Plan and Design Statement, which is at this moment being delivered to all households within the Parish. This document could well help you in realising what the community want from the Egerton Centre, Library and High School. On our web site at <a href="https://www.forsbrookparishcouncil.org.uk">www.forsbrookparishcouncil.org.uk</a> you will find details of the Parish Plan Questionnaire, the Survey Results in edited format and also the Survey Results listing all the individual comments, which residents have made. The Parish Plan and Design Statement will be included on the website shortly.

In the past we have asked for a breakdown of the income from the Egerton Centre together with usage and by whom. Is it possible to provide us with this information or do we need to request it under The Freedom of Information Act?

If you do not want to work or consult with the Parish Council it would be appreciated if you would let us know."
