3. OPEN SESSION.

3.1 Residents Issues.

Public footpath 4a.

Mr. and Mrs. Dean said that the overgrown hedge around the school on the above footpath was obstructing pedestrian access.

Agreed to write to Staffordshire County Council Rights of Way Department to ask them to contact Blythe Bridge High School and residents whose boundaries were adjacent to the footpath.

Planning Application 00521/OUT – land adjacent to 11 Cypress Grove, Blythe Bridge.

Mrs. Jean Shenton and Mrs. Susan Durose of 5 and 7 Cypress Grove, Blythe Bridge said that they had attended the Planning Applications Committee meeting on 11th August 2011 and were disappointed that members had approved the above application by one vote. To reach this decision two voting procedures had to be carried out, which was confusing. The first decision was 5-5 with the Chairman casting his second vote to refuse the application. Another voting procedure was called because presumably the number of members in attendance on the Planning Applications Committee did not match the number of members who had voted. The second vote approved the application 6-5. Many objections had been sent to Staffordshire Moorlands District Council Planning Department and objectors felt that the application had been put before the Planning Applications Committee very quickly with not all objectors receiving an acknowledgement of their objections or notice that the application was going before the Planning Applications Committee.

Chairman Councillor Mrs. G. Burton suggested that residents request a meeting with SMDC Officer Mark Trillo to ask him to address any concerns.

3.2 County Council Report.

In the absence of County Councillor W. Day there was no report, but he had sent a message to say that he was still trying to arrange a meeting between Parish Councillors and Highway Officers.

Parish Assembly Meeting of 28th July 2011.

Chairman Councillor Mrs. G. Burton reported that she along with Councillor Miss S. Farr and Councillor A. J. Mould had attended the recent Parish Assembly meeting, the minutes of which will be sent through to Council in due course. There were presentations on Recycling and Sustainable Energy.

Station Adopters Meeting at Derby.

Councillor Mrs. N. A. Stanier said that she along with other Station Adopters for East Midland Train Stations had attended the above meeting and was pleased to report that Blythe Bridge Station was again through to the final of the Best Small Station. The awards ceremony is being held in Derby on 9th September 2011 and she along with her husband will be attending.

9. PLANNING.

9.1 Planning Applications:

00592/ADV – Britannia Building Society, 319 Uttoxeter Road, Blythe Bridge – 1 internally illuminated fascia and 1 internally illuminated double side projecting sign.

RESOLVED:

To ask the Planning Officer to consider if the signs would be a distraction to motorists or visually intrusive to nearby residents living above their retail premises in this busy traffic area, which is adjacent to a primary school and next to the entrance to the busy Late Shop.

9.4 Planning matters.

Planning application 00521/OUT – the erection of two semi detached houses in the garden of 11 Cypress Grove, Blythe Bridge and the formation of a revised plot boundary to 11 Cypress Grove.

As referred to previously in the minutes the above application has been approved.

10. CEMETERY:

10.1 Cemetery Report.

Chairman Councillor Mrs. P. Shufflebotham reported that she visited the Cemetery at the weekend and it appears that youth in vehicles are again congregating on the car park.

Agreed to ask the local police officers to monitor the situation.

10.2 Cenotaph at St. Peters Church, Forsbrook.

Council has received a quotation of £918.00 for masonry cleaning and minor chip repairs to the plinth of the Cenotaph.

Funding of up to 50% of the cost may be available through the District Council Enhancement Scheme but it was noted that a decision on whether or not to award funding will not be made by the Moorlands Partnership Board until their next meeting in November, which will be too late for the work to be carried out before Remembrance Sunday.

RESOLVED:

- 10.3 Current Cemetery Development.

Council has received a quotation of £220 from Town and Country Services for weed treating the present cemetery development. It was noted that the cost is slightly higher than weed treating the cemetery field because this will need to be done by hand rather than by tractor.

RESOLVED:

- To accept the quotation and arrange for the work to be carried out as soon as possible.

11. ENVIRONMENT:

11.1 Environment Report.

Chairman Councillor Mrs. G. Burton (Chairman of the Environment Committee) gave the following report:

Foxfield Railway.

There has been several complaints regarding noise levels at an event held at Foxfield Railway over a three day period on 22nd, 23rd and 24th July 2011.

A resident who felt the noise was unacceptable has written to Foxfield Railway and received a reply from the Chairman.

(The reply was read to Council).

Chairman Councillor Mrs. G. Burton said that when she received the complaints on the Saturday night, she contacted the Police who said that a Police Officer would attend. Unfortunately, no one was available in the Environmental Health Department at the District Council but on Monday 25th July she said that she spoke to an Officer in the District Council Licensing Department to ascertain what time the Licence was up to on the Saturday night as a resident heard loud music until 3.15am on the Sunday morning. The Licence for the event was up until 11.30pm. A complaint has also been made regarding bad language from the bands.

The Environmental Health Department has provided an 'out of hours' mobile number – 07976268930 but this will only be available until the end of August when new arrangements are being put in place.

The Police can only deal with Crime and Disorder offences at these type of events, any other issues are dealt with by the District Council.

Should any residents have any concerns they need to contact SMDC Environmental Health Department and the police so that records can be kept.

Chairman Councillor Mrs. G. Burton said that as District Councillor she has sent a letter to Foxfield Railway, with copy to the Police and Licensing Department and proposed that Council do the same. **Agreed.**

Clothesbank Shop, Chapel Street, Forsbrook.

During the last week there have been several complaints regarding the two large signs on the front of the above shop and 'A' board being inappropriate in this village location. Residents are also concerned that this type of business could exacerbate highway problems in this already busy traffic area due to an increased number of vehicles taking bags of clothing into the shop and the transit vehicle transferring the clothes to their main depot. The SMDC Planning Enforcement Officer has been contacted and will be undertaking a site visit. The situation needs to be monitored and the police notified if vehicles are causing an obstruction.

Community Action Day.

The clerk has provided SMDC with details for another Community Action Day in Blythe Bridge and Forsbrook. Work identified for the Community Payback team is maintenance of shrub beds at Forsbrook Parish Cemetery and garden beds at Blythe Bridge Railway Station.

Chairman Councillor Mrs. G. Burton proposed that Councillors and residents again carry out a litter pick of hot spot areas similar to last year. Arrangements can be made for SMDC to assist with visibility vests, litter pickers, bags and removal of rubbish.

Communities Mean Business Funding.

An 'Expression of Interest' form for the above funding is now being finalised. The extension to the changing rooms does not meet the criteria for funding under this scheme so other avenues need to be explored. A total of £30638 is being applied for to provide additional play equipment consisting of BMX track, pendulum swing and traditional swing, totalling £21738 and the purchase of scrubland from the village hall, urgent work to trees following a risk assessment, solicitors fees (estimated) and landscaping, totalling £8900. The bid for funding is being presented by Chairman Councillor Mrs. G. Burton to the Moorlands Rural Panel on Tuesday 1st November 2011 with the final presentation to LAG members on Thursday 24th November 2011.

Community Rail Awards 2011 Photographic Competition.

The above competition closes on 4th September 2011. There is a photograph of the volunteers for Blythe Bridge in the competition.

Crossfield Avenue, Blythe Bridge.

Complaints have been received again about misuse of the open space in Crossfield Avenue, which is owned by the Parish Council. Chairman Councillor Mrs. G. Burton proposed that this be discussed at the Environment Committee meeting on 16th August 2011. **Agreed.**

Play Day held on 13th August 2011 on Blythe Bridge Recreation Ground.

Chairman Councillor Mrs. G. Burton reported that the above event went extremely well. Parish Councillors who volunteered to run a bric-a-brac stall raised £50, which will be donated to Blythe Bridge Home Link.

Councillor Mrs. C. R. Hopley said that 411 raffle tickets had been sold and Councillor F. J. Hopley read a list of the recipients of the winning tickets, details of which he said would be printed in the local press.
