Standing Orders were suspended.

#### 3. OPEN SESSION.

Chairman Councillor Mrs. G. Burton welcomed Sgt. Nigel Spooner and explained that he was representing Inspector Clare Riley who could not attend because of an urgent last minute engagement.

3.1 Sgt Nigel Spooner addressed Councillors concerns/questions as follows:

#### Police Cover.

The same number of officers are deployed in Blythe Bridge and Forsbrook – PC Steve Critchlow, PC Neil Lawton, PCSO Daniel Peake with additional part time cover from PCSO Kash Ullah and PCSO Adam Charlesworth. The area they now cover is Blythe Bridge, Forsbrook, Caverswall, Draycott and Tean. All calls to 101 are allocated an incident number unless the caller is seeking advice.

#### Anti Social Behaviour Concerns.

There is a total of 6/8 hardcore youth from Blythe Bridge, Meir and Meir Heath who are causing problems. At least six have been invited to the Police Station along with Ian McLackland from SMDC Community Safety Department. The youth have been entered into anti social behaviour contracts, which is the first step towards anti social behaviour orders. This has happened within the last ten days and PC Steve Critchlow is still obtaining statements. If in the meantime any of the youth step out of line they could find themselves before the court.

## Sale of Alcohol to the Underaged.

Operations in partnership with Trading Standards are ongoing and identified premises will be visited.

# Parking Issues.

Following on from the attendance at a Council meeting of Inspector Lee Crowther, PCSO Daniel Peake has been liaising with your Chairman Councillor Mrs. G. Burton regarding the problem areas – Trent Road/Dove Road, Stallington Road and the centre of Blythe Bridge. Parking on yellow lines comes under the remit of Staffordshire Moorlands District Council Civil Enforcement Officers and the police deal with vehicles that are causing an obstruction. The police are working with the schools and letters are being sent to parents telling them that there will be no more warnings and penalty tickets will be issued if they cause an obstruction. There is no action that can be taken to prohibit the school bus parking adjacent to St. Peters Church unless the police consider it to be causing an obstruction. Officers will investigate the concern regarding vehicles parked on the grass verge in Dilhorne Road, Forsbrook and will take action if it is viewed that they are causing an obstruction.

# Speeding.

Speeding checks are ongoing. Caverswall Old Road between the junction with Hillside Avenue and Caverswall Road is derestricted which means that vehicles can travel up to 60mph.

# Scrap Metal Dealers.

Licences are checked on a regular basis and generally found to be in order but there are some unscrupulous scrap metal dealers.

Chairman Councillor Mrs. G. Burton thanked Sgt. Nigel Spooner for attending the meeting and giving members an update.

# 3.3 County Council Report.

County Councillor W. Day gave the following report:

# Gulley Covers.

Scrap metal merchants are stealing gulley covers across Staffordshire so if you witness anything suspicious please report immediately to the Police.

# Slow Road Markings.

Staffordshire County Council no longer provide 'slow' road markings as this is too costly. Dilhorne Parish Council has asked for costings should they wish to undertake this themselves and commit to regular maintenance and when this information is available it can be shared with Forsbrook Parish Council.

#### Cemetery Concealed Entrance Sign.

Need to seek clarification from Staffordshire County Council Officer Maryanne Raftery regarding the recent stance that these signs do not meet with DfT regulations and therefore cannot be provided.

#### Flooding adjacent to Chandri Cottage.

Cleaning of gulleys across Staffordshire County Council is currently being carried out so hopefully this issue will be resolved.

The clerk added that with regard to this location Staffordshire County Council has identified and scheduled necessary work but given no specific time scale.

# 4. INFORMATION AND REPORTS FROM REPRESENTATIVES ATTENDING 'OUTSIDE' MEETINGS'.

4.1 The Localism Bill – meeting attended by Councillor F. J. Hopley on 4<sup>th</sup> November 2011.

Councillor F. J. Hopley gave the following briefing on the overall effect of the Act taken from the Communities and Local Government publication entitled 'A plain English guide to the Localism Act' – pages 21 and 22.

# New freedoms and flexibilities for local government.

The Act:

- gives local authorities everywhere the formal legal ability and greater confidence to get on with the job of responding to what local people want
- cuts red tape to enable councillors everywhere to play a full and active part in local life without fear of legal challenge
- encourages a new generation of powerful leaders with the potential to raise the profile of English cities, strengthen local democracy and boost economic growth
- enables ministers to transfer functions to public authorities in cities in order to harness their potential to drive growth and prosperity
- reforms the governance of London so that more power lies in the hands of elected representatives who are democratically accountable to London citizens

# New rights and powers for local communities

*The Act:* 

- makes it easier for local people to take over the amenities they love and keep them part of local life
- ensures that local social enterprises, volunteers and community groups with a bright idea for improving local services get a chance to change how things are done
- enables local residents to call local authorities to account for the careful management of taxpayers' money

# Reform to make the planning system clearer, more democratic and more effective The Act:

- places significantly more influence in the hands of local people over issues that make a big difference to their lives
- provides appropriate support and recognition to communities who welcome new development
- reduces red tape, making it easier for authorities to get on with the job of working with local people to draw up a vision for their area's future
- reinforces the democratic nature of the planning system pass power from bodies not directly answerable to the public, to democratically accountable ministers

# Reform to ensure that decisions about housing are taken locally The Act:

- enables local authorities to make their own decisions to adapt housing provision to local needs and make the system fairer and more effective
- gives local authorities more control over the funding of social housing, helping them to plan for the long term
- gives people who live in social housing new ways of holding their landlords to account and make it easier for them to move

<sup>&</sup>quot;Taken together, the measures in the Act mean.

This is, in sum an Act with the potential to effect a significant change in national life, passing power to a local level, creating space for local authorities to lead and innovate and giving people the opportunity to take control of decisions that matter to them.

Together with other wider Government reforms, putting the Act into practice will represent a major milestone towards the transfer of power and control set out in the coalition agreement.
