## 3. OPEN SESSION.

## Standing Orders were suspended.

#### 3.1 Residents Issues.

Caverswall Road, Blythe Bridge – road surface condition and blocked drains.

County Councillor W. Day said he would get the Staffordshire County Council Reactive Inspector to undertake a site visit.

# 3.2 County Council Report.

County Councillor W. Day gave the following report:

## Scarratt Drive, Forsbrook.

Staffordshire County Council has carried out a site visit and identified the need for grit bins at this location, but has ceased ordering any new stock in this financial year and is looking for a new supplier. There are two used grit bins at the Ladderedge Depot and these are being assessed to see if they are fit for re-siting.

(Note: Two grit bins have now been installed at Scarratt Drive, Forsbrook).

Footway – adjacent to Forsbrook Wine Shop, Chapel Street, Forsbrook.

Staffordshire County Council has agreed that the recently installed drain at the above location is a hazard and they are presently trying to find a different safer type of gully cover.

#### Potholes.

The Reactive Inspector has marked out many drains in Forsbrook Parish for repair but in many cases the time scale for carrying out this work is not meeting the target. Councillors reported that potholes have been repaired in Hillside Avenue, Dilhorne Road, Meadow Close and Newclose Avenue.

Staffordshire County Council proposals to sub-contract out some school services.

The above proposals have been called in because a full consultation was not carried out. If the proposals are approved it will mean that Staffordshire County Council will only be 49% shareholders in providing some services. This could affect jobs, which is a concern with some Councillors and also some schools. The proposals will mean that 400 employees will be transferred over to the new company.

Overgrown hedge adjacent to the Butchers Arms and 56 Cheadle Road, Forsbrook.

In response to a question raised by Councillor A. E. Wilson, County Councillor W. Day advised that Staffordshire County Council have written to Punch Taverns the owners of the Butchers Arms requesting that they attend to the overgrown hedge and Staffordshire County Council Highway team will deal with the overgrown hedge adjacent to 56 Cheadle Road, Forsbrook.

## 6. MATTERS ARISING FROM MINUTES.

6.1 Minutes dated 19<sup>th</sup> November 2012 – Page 87 – agenda item 3.1. Foxfield Light Railway Society Limited.

Chairman Councillor Mrs. G. Burton read letter received from Matt Burton the Licensing Officer at Staffordshire Moorlands District Council.

"I thank you for your letter dated 20<sup>th</sup> November which we received on 26<sup>th</sup> November 2012. I apologise for the delay in responding but I have been on annual leave.

In answer to your question relating to why the conditions proposed by Environmental Health for the recent licence application do not apply to TEN's it is because legally they cannot. Unless the premises already had specific conditions pertaining to regulated entertainment on their premises licence they could not be added to a TEN.

We are aware of, and have recorded on file, the complaints and issues surrounding the event that took place in October. Environmental Health and Staffordshire Police Licensing also have these complaints documented. Only these two authorities have the power to object to a TEN and having spoken to them separately it is my understanding that they will object should another TEN be submitted in relation to a proposed event at Foxfield Railway.

6.2 Minutes dated 19<sup>th</sup> November 2012 – Page 89 – agenda item 7.1 – Staffordshire Moorlands District Council Civil Enforcement Officers.

Chairman Councillor Mrs. G. Burton read email received from Carole Machin from the Parking Services Department at Staffordshire Moorlands District Council.

"Thank you for your letter requesting regular patrols at Forsbrook and Blythe Bridge from the Civil Enforcement Officers (CEO's).

We regularly send our officers out to both Forsbrook and Blythe Bridge but unfortunately such is the demand from all the schools across the district it may not always be at the times you need, we will try to get our Officers there in the near future at around 3pm for you. I cannot guarantee any Penalty Charge Notices will be served as the drivers generally move on when they see the CEO's but they will have a deterrent effect."

Chairman Councillor Mrs. G. Burton read email received from the Planning Enforcement Department at Staffordshire Moorlands District Council.

"I refer to your recent complaint regarding the above matter. I have now had the opportunity to carry out a preliminary investigation. At this stage it appears that your concerns warrant further investigation and I have made your complaint into a Planning Enforcement File. The new reference number for this file is 12/00071/BOC. You should quote this number in all future correspondence.

The ongoing investigation could involve careful negotiation and a series of site visits to ensure that the Planning Authority is taking the most appropriate course of action. 00827/FUL – Farm Cottage, Cheadle Road, Blythe Bridge – dropped kerb.

Reasons: "(1) The proposed development fails to make adequate provision for the turning of vehicles within the site curtilage resulting in an increase in the likelihood of highway danger due to drivers having to manoeuvre into the main A521 Cheadle Road in a reverse gear and is therefore contrary to Staffordshire Moorlands Local Plan saved policies B13 and T14 and the Staffordshire and Stoke-on-Trent Structure Plan policy T13. (2) The applicant has failed to demonstrate pedestrian visibility splays of 1.5m x 1.5 m either side of the proposed access and is therefore contrary to Staffordshire Moorlands Local Plan saved policies B13 and T14 and the Staffordshire and Stoke-on-Trent Structure Plan policy T13. "
