3. OPEN SESSION.

Standing Orders were suspended.

3.1 Residents Issues.

Residents attending the meeting raised the following issues.

3.1.1 Parish Council.

Two residents thanked Councillors for their continued hard work and commitment.

3.1.2 Surface water drainage in Caverswall Road, Blythe Bridge.

Surface water is constantly flowing down Caverswall Road from the junction with Foxfield Steam Railway and Heath House Farm and this is adding to the number of potholes that are appearing and the eroding the road surface.

County Councillor W. Day agreed to raise this issue with Staffordshire County Council's Reactive Inspector requesting that he carries out a site visit to assess the situation.

3.1.3 Cars parked on the junction of Caverswall Road/Uttoxeter Road, Blythe Bridge.

The number of cars that are parked on Caverswall Road near to the junction with Uttoxeter Road is considered by residents to be dangerous. Motorists are finding it difficult to exit and enter Caverswall Road because they have to navigate around the parked cars.

Chairman Councillor Mrs. G. Burton said that local police officers continue to monitor the situation and will take action against any motorists who park incorrectly or cause an obstruction.

3.2 County Council Report.

County Councillor W. Day gave the following report:

The following **highway expenditure** in Forsbrook and Blythe Bridge was noted:

£550,000 on structural maintenance of Cheadle Road, Forsbrook.

This figure does not include the £10000 cost for improving the Cheadle Road/Uttoxeter Road/Stallington Road junction, which was funded by County Councillor W. Day from Staffordshire County Councils member's initiative scheme.

£200,000 approximately on preventative carriageway maintenance (surface dressing) on some footways in Blythe Bridge and Forsbrook.

£70,000 on preventative footway maintenance (slurry sealing) on some footways in Forsbrook.

Potholes and Drainage Issues.

At the full meeting of Staffordshire County Council Cabinet members on 14th February 2013 it was proposed by some members that a further £5m from reserves be allocated to the highway budget to repair potholes and improve drainage. This proposal was rejected.

In response to questions raised by members County Councillor W. Day responded as follows:

Re-erection of 30-mile speed sign – Stallington Road, Blythe Bridge. Flooding on highway adjacent to Chandri Cottage – blocked drains adding to this problem.

Will request updates on these issues.

Cars for sale on the grassed area adjacent to the Tesco roundabout.

As this land was in Fulford Parish the clerk was requested to email the clerk of Fulford Parish Council asking what measures County Councillor Ian Parry intended taking to eliminate this problem.

Standing Orders were reinstated.

9. PLANNING.

9.1 Planning Applications:

The Gingerbread Centre

00023/FUL (Retrospective application in part) - Land adjacent to Thornley, Boundary Road, Boundary – improvement of existing agricultural/horticultural access drive inclusive of parking and turning area.

Chairman Councillor Mrs. G. Burton reported that this is the second application, which has come before Council, which was refused by Staffordshire Moorlands District Council for the following reasons:

"By reason of its length, overall size, domestic and ornate appearance the driveway/parking and turning areas appear as a significant and harmful domestic encroachment into the Green Belt and Special Landscape Area of which the site forms a Whilst there is no dispute that there was previously an agricultural access to the application site, there is now no justification as to why such an ornate development should be approved. It is recognised that the applicant is presenting a case for a new agricultural/residential driveway, parking/turning areas and areas of hard standing on the basis of agricultural need and highway safety. The applicant fails to demonstrate that there is sufficient agricultural need for the development in this particular location, nor are there any justifiable highway safety reasons for allowing the development. application is considered to be contrary to policies N7, N8, N9, B13 and E4 of the Staffordshire Moorlands Local Plan, policies D5A and NC2 of the Staffordshire and StokeThe application then went to appeal and was dismissed on 17th September 2012. The Inspector found that "The engineering operations to form the access drive and parking and loading area comprise of inappropriate development in the Green Belt. The substantial harm that this causes, together with the harm to the character and appearance of the area that I have identified, is not clearly outweighed by the benefits that the proposal would bring in terms of making beneficial use of the land, greater convenience for the appellant and the limited improvements to highway safety, whether assessed separately or jointly. I conclude that very special circumstances to justify the development do not exist. The development is, therefore, contrary to national policy relating to Green Belts, as well as to development plan policies that aim to safeguard the character and appearance of the Green Belt and Special Landscape Area. For the reasons given above, I conclude that the appeal should be dismissed."

The application before Council now is in part retrospective – as building work/change started in September 2010 but has not yet been completed.

RESOLVED:

For spond to the above planning application stating that members of Forsbrook Parish Council have noted the history of the site and the fact that both Staffordshire Moorlands District Council and the Planning Inspectorate have previously refused planning permission for similar proposals and for these reasons Council would not want planning permission granted unless all the previous concerns for the refusals have been fully addressed, particularly as the site lies within Green Belt and Special Landscape area.
