#### 3. OPEN SESSION.

Standing Orders were suspended.

#### 3.1 Police Update:

PCSO Adam Charlesworth reported that anti social behaviour for his area was down 50% for the period January-March 2014 compared to the same period in 2013 with Staffordshire Moorlands area down 5%. There were 12 incidents reported between this period, seven of which have been identified as being carried out by the same group. Parents of the juveniles in this group have been visited and the police are also working with the District Council and housing association as tenancy agreements state that action will be taken against families who cause anti social behaviour. Two incidents were neighbour disputes and three were related to disagreements. Crime figures for theft, burglaries etc. were the same with Staffordshire Moorlands area showing an increase of 5%.

PC Alex Gould and PC Mark Warrilow have moved to Leek policing area and PC Dave Stubbs has joined the local policing team.

Details of forthcoming Police Surgeries have been advertised on the notice boards and are also on the Parish Council's web site.

In response to questions raised PCSO Adam Charlesworth said that:

- There have been no issues with regard to air guns in the area.
- No issues have been reported regarding motorbikes causing a nuisance and Councillors and residents were asked to report concerns immediately to the 101 police number to enable a police officer to be deployed when offences were actually taking place. He added that this also includes vehicles when they are causing an obstruction.

#### 3.2 Residents Issues.

#### 3.2.1 Foxfield Steam Railway.

Mr. Mark Wagstaff, Director at Foxfield Steam Railway provided Councillors with further information regarding events and proposals for 2014.

A resident's discount scheme will again operate in 2014.

Foxfield will be working with Blythe Bridge Library, Stoke-on-Trent Archives and Staffordshire University with regard to a World War 1 display.

There will be a live music event on August 23<sup>rd</sup> from 3.00pm to 10.00pm

A beer festival with a 60/70/80/90's and 'naughties theme will take place in August 2014.

Planning permission is being sought for permanent pitches for five caravans.

3.2.2 Barlstone Avenue, Blythe Bridge – subject: Cold Calling Sign.

Chairman Councillor Mrs. G. Burton said she would collect the sign and arrange to have it re-instated.

3.2.3 Footpath 5a linking Uttoxeter Road to Jasmine Close, Blythe Bridge – subject: Damaged wooden fence.

Chairman Councillor Mrs. G. Burton said that Staffordshire County Council Rights of Way Department has written to the owner of the fence.

3.2.4 Jubilee Gardens, Blythe Bridge – subject: Provision of waste bin.

The clerk said that she would get an update from Staffordshire Moorlands District Council Environment Services. (Note: A waste bin has now been installed).

3.2.5 Accidents/Closure of the A50 – subject: Diverted traffic impacting heavily on the congestion on Uttoxeter Road and spine roads in Blythe Bridge to the extent that Blythe Bridge and Forsbrook become completely gridlocked.

Chairman Councillor Mrs. G. Burton said that she has already spoken with County Councillor W. Day regarding several highway issues and a site meeting is being arranged with Staffordshire County Council highway officers.

3.3 County Council Report.

County Councillor W. Day gave the following report.

The Neighbourhood Highway Team will be working in the Parish week commencing 14<sup>th</sup> April, 2014.

The system for reporting and monitoring work on potholes and drainage issues is not working efficiently and Staffordshire County Council is taking steps to improve this.

Standing Orders were reinstated.

# 4. INFORMATION AND REPORTS FROM REPRESENTATIVES ATTENDING 'OUTSIDE' MEETINGS.

Councillor J. W. Burgess reported that at the last SPCA Executive meeting he was advised that a consultant is being employed to try and push for a HS2 link in Stoke-on-Trent.

He also said that he has been nominated as a member of the CPRE committee but as yet has not been invited to any meetings and he believed there was a meeting on Wednesday 19<sup>th</sup> March.

The clerk was asked to liaise with SPCA to ensure that CPRE had Councillor Burgess's contact details.

#### 6. MATTERS ARISING FROM MINUTES.

6.1 Minutes dated 17<sup>th</sup> February 2014 – Page 119 – agenda item 11.3 – Butchers Arms.

The following response from PCSO Jonathan Staples was noted:

"I have been in to see the licensee and he agrees that there is an issue. He has been very understanding and he has promised to have some signs made asking customers not to park on the footpath and he will attach them to the small fence adjacent to the pavement. He is also going to put a notice up inside the pub to make the locals aware of the issue. The licensee has a meeting with his area manager and is going to ask for funding to improve his car park by using the grassed off area to the rear of the premises. He is very keen to help and to assist in solving this issue as soon as possible and is open to any suggestions."

The clerk was asked to respond to the email to see if the licensee of the Butchers Arms would be prepared to contribute towards the cost of installing bollards on the footway, providing Staffordshire County Council approved the scheme.

6.2 Minutes dated 17<sup>th</sup> February 2014 – Page 114 – agenda item 7.1 – Tater Lane – installation of bollard.

The following response from Victoria Ellis, Community Projects Officer, Staffordshire Moorlands District Council was noted:

"I have already spoken with Staffordshire County Council Officer Rob Steele about this suggestion, but as a bollard would restrict access to the vehicle turning point it would be very unlikely to be approved. I will ask Rob Steele to have another think at what we could do, as I agree unless this area is made inaccessible we will always have problems."

6.3 Minutes dated 17<sup>th</sup> February 2014 – Page 113 – agenda item 3.1.6 – delivery vehicles to Tesco parking dangerously and causing an obstruction.

The following response from Staffordshire Moorlands District Council planning/enforcement officers was noted:

"I refer to your recent concerns received on 25.02.14. You have alleged that delivery vehicles are off loading from the highway.

Your complaint has been investigated and enquiries have been made with the owner of the above address. The Council has now given your complaint consideration and is in the position to provide you with the following response.

On this occasion the Council has decided to take no further action in respect of your allegation. This is because we have spoken to the management of the above premises and given them a strong warning that any further breach of condition 3 of planning permission 12/00603/FUL would result in enforcement action and the Council has been assured that this matter will be addressed and should see this issue resolved.

Could I ask that if you are informed of any future incidents regarding deliveries the date and time of the occurrence would be very much appreciated.

Thank you for bringing your concerns to the Council's attention. If there are any significant changes in circumstances you may notify the Council and officers may review your case. However, at this present time your complaint is closed for the reasons given above."

It was also noted that G4 security vehicles are causing an obstruction by parking on the footway when servicing the ATM machine.

The clerk was asked to bring this matter to the attention of Staffordshire County Council highway officers and County Councillor W. Day.

# 9.1 Planning Applications:

"The application site is located within the Blythe Bridge and Forsbrook Village Within such areas extensions to domestic properties can Development Boundary. often be supported subject to all other material planning considerations being satisfied. Extension to dwellings should be of a good design in their own right and garages should be subordinate and modest in their size. Good design is particularly important for developments within visually prominent locations such as this in order to avoid visual harm to the street scene. By reason of its excessive footprint size and overall bulk, the proposed extension is unacceptable and would be an overlarge and disproportionate addition to this visually prominent dwelling. The addition would not relate well to the existing house or its surroundings of modestly sized dwellings. For these reasons the proposed development is contrary to Saved policy B13(a) of the Staffordshire Moorlands Local Plan, adopted Supplementary Planning Guidance; Design Principles for Development in the Staffordshire Moorlands, policy DC1 of the Core Strategy (Revised Submission Document) and the national Planning Policy Framework including Chapter 7: Requiring Good Design."

- 12.3 Unity Trust Bank subject: Transfer of monies.

Chairman Councillor Mrs. G. Burton provided members with background information regarding the financial assets of Forsbrook Parish Council.

The Council's internal auditor has suggested that the Parish Council should not hold all its monies in one bank account. The current account is with the Co-operative Bank plc.

The clerk has researched suitable banks and the Unity Trust Bank is a small bank based in Birmingham. The intention is to continue with the Co-operative Bank for the day to day running of Council's affairs but to transfer £75000 into the Unity Trust Bank. The account will be an interest bearing internet account but monies can be paid in at any Co-operative Bank, local Post Office or high street bank. It is proposed that account signatories (3) will be the Chairman, Vice Chairman and Councillor responsible for Finances. The remaining ten Councillors will need to be listed as key account parties.

#### **RESOLVED:**

To open an account with the Unity Trust Bank and to transfer £75000 from the Co-operative Bank plc.
