3 OPEN SESSION

3.1 Residents Issues

Litter across the recreation ground is being mowed, causing the cans and bottles to be strewn across the area. – Clerk will speak to the Lengthsman.

Certain properties along Elmwood Drove are allowing their front garden plants to grow into the pavement making it difficult for buggies and pedestrians to pass. – Clerk to contact SCC Highways

Various pieces of football paraphernalia were presented to the Parish Council (hammer, spikes, tapes) these items had been left on the pitch along with a step ladder following on from Sundays game. A discussion took place and Councillors asked the Clerk to write to The Butchers Arms Football team and state that should this happen again the cost of cleaning the area up would be passed onto them.

A member of the public asked why the Parish Council had not publicised the answers to SMDC Public Consultation on the housing sites. The Clerk explained that the response had been submitted to SMDC and should anyone wish to view the hard copy response then they could come visit the clerk's house to see it or she could email it to them. Chairman Councillor Frank Hopley stated that the Parish Council were doing their best and that they had been kept in the dark over a lot of the issues. County Councillor W Day reiterated that planning issues at SMDC were tricky and that the consultation had been a disaster.

The same member of the public went onto to ask why the Parish Council had not held a cemetery meeting since 2013. The clerk explained that there was a meeting held in March and if the minutes were not on the web site this was unfortunately an oversight and she would arrange for them to be added the next day. He then went onto ask about a grid at the cemetery which he had reported a few months ago. The clerk stated that it had been repaired, unfortunately he did not feel that it was a satisfactory standard. Councillor P Shufflebotham said we would inspect and if the Parish Council thought it necessary they would ask for further repairs to be instigated.

It was reported that the green area on Elmwood Drive was overgrown. Cler to report to SMDC

3.2 COUNTY COUNCILLOR REPORT

Chairman Councillor Mr F Hopley welcomes back Councillor W Day.

Councillor Day reported the following:-

The Library had recently been hit by a vehicle which has caused substantial damage. As a result the library was going to undergo a programme of repair:-

!st Phase -23.11.15 Library will be open whilst the repairs are ongoing. 2^{nd} Phase -7.12.15 - 21.12.15 the Library will be closed whilst these repairs are undertaken.

Any books which are due back during the closed period will not incur fines.

Councillor Day went onto to explain that he had recently been to a meeting at Staffordshire County Council regarding the medium term financial strategy.

As from 2020 SCC will not receive any funding from central government and will need to look to other areas of raising funds. This would obviously have an impact on Council Tax bills and people should be prepared to expect a rise in the amount they pay.

Councillor T Mould asked if SCC would be expected to give money to the government, Councillor Day said no.

Chairman Councillor Mr F Hopley said that he anticipated that a lot of the small voluntary groups would disappear.

4. INFORMATION AND REPORTS FROM REPRESENTATIVES ATTENDING OUTSIDE MEETINGS INCLUDING DISTRICT COUNCILLOR K FLUNDER

District Councillor K Flunder briefed the meeting on the progress of the local housing consultation.

He stated that local people needed to support the most feasible option from the sites. Councillor Fluner and Councillor Herdman were attending a workshop in December to look at the local responses for their area and this will be followed by the Parish Council meetings at SMDC where all responses will be able to be viewed and discussed.

There will be two further periods of consultation in and the final results will be forwarded to the Home Office in March 2017.

Chairman Councillor Frank Hopley said the road infrastructure was the main issue and that we cannot keep building houses.

County Councillor W Day advised that The Parish Council ask for an area review.

An email was read out to the meeting from PCSO Adam Charlesworth regarding Community Speed Watch.

I have asked about a Community Speed Watch group being set up in the area in 2012, but there was no real interest at the time. A few years ago, these were the following prices:

"To begin with the scheme will require a minimum of 6 volunteers and will need funding support from either the local Councillor or Parish Council. The equipment costs £801 for the hand held device, £107 for 2 fold out road signs and high visibility waistcoats are priced from £5.15 to £7.48 dependent on size. Some schemes have 3 high visibility waistcoats which are shared and other schemes have 1 garment per volunteer. Obviously the more high visibility waistcoats that are purchased the greater the costs."

I will double check these prices with you and get back to you when I can. Ideally, if the Council agree to pay these costs to set up the group, and six volunteers can be found, then I will need the details of somebody picked to be the co-ordinator and pass them onto the Speed Watch department. Somebody there will go through invoicing etc. and organise for training sessions for the volunteers and set it all up.

County Councillor W Day stated that if the Parish Council could find the volunteers he would fund the equipment via his County Council Members initiative so long as he received an application before 06.12.15

Councillor R Mancey stated that this could only be beneficial to any objections we may have for housing consultation.

Clerk – will investigate the current costs and future costs of the scheme and apply for the grant.
